










#### Launch of ACA Research Reports



In June, **The Anti-Counterfeit Authority** in collaboration with (ACA), University, released the findings of a comprehensive survey aimed at assessing the prevalence, trends, and impact of counterfeit products in the Kenyan market. The study focused on four key sectors: alcoholic beverages, automotive spare parts, energy, electronics and electrical, and pharmaceuticals medical equipment.

As part of the survey, a ranking of the ten most commonly counterfeited automotive components was developed. Spark plugs emerged as the most frequently counterfeited item, followed closely by engine parts such as pistons and crankshafts. Transmission components were found to be the least counterfeited among the ten.

In light of these findings, consumers are strongly advised to exercise caution when purchasing automotive spare parts. The use of counterfeit components can have serious consequences, including increased maintenance costs due to frequent replacements, and potentially fatal accidents caused by substandard or defective parts.

### Kenya Secures ¥25 Billion Samurai Financing from Japan

Kenya has signed a landmark ¥25 billion (KSh 22 billion / USD 169 million) Samurai financing facility with Japan, marking a major step in accelerating the country's automotive ambitions and energy reforms. The agreement was signed during the TICAD 9 Summit in Tokyo between Foreign and Diaspora Affairs Cabinet Secretary Musalia Mudavadi and Nippon Export and Investment Insurance (NEXI).

The funds will be channeled into three key areas;

- Automotive Industry (¥15 billion / KSh 13.1 billion):
- Energy Sector (¥5.5 billion / KSh 4.8 billion):
- General Budget Support (¥4.5 billion / KSh 3.9 billion):

#### Automotive Sector Multi-Stakeholder Engagement Meeting

In August, KAM convened a high-level meeting together that brought automotive sector members and key government agency representatives to review the progress, challenges, and policy priorities of Kenya's automotive industry. This engagement facilitated critical discussions among industry leaders and government officials on the sector's challenges, opportunities, and future direction. Key topics included regulatory reviews of Legal Notices 112 and 84, e-mobility, industry incentives, standards, and pending legislation, all aimed at strengthening industrialization, attracting investment, and creating jobs in the sector.



APMA board member and KAM Parts Sub-sector chair, <u>Nephat Njeng'wa</u> emphasized the importance of offering greater incentives to motor vehicle assemblers to progress to CKD Level 3. This transition, he noted, would support higher localization of components and create more jobs. He also commended the government for supporting the localization of 14 motorcycle components under Legal Notice 112.
